ANNUAL ELECTION AND 2010-2011 BUDGET VOTE – May 18, 2010

MINUTES

The election of members of the Board of Education and the vote upon appropriating the necessary funds to met the estimated expenditures and the vote upon all propositions involving the expenditures of money, or authorizing the levy of taxes, took place at the Ichabod Crane High School Gymnasium, Valatie, NY between the hours of 8AM and 9PM.

PROPOSITION NO. 1 – BUDGET

SHALL THE FOLLOWING RESOLUTION BE ADOPTED TO WIT:

RESOLVED, that the Board of Education of the Kinderhook Central School District, Columbia and Rensselaer Counties, New York be authorized to expend the total amount of \$37,738,582 during the school year 2010-2011 and to levy the necessary tax therefor?

PROPOSITION NO. 2 – BUS PURCHASE PROPOSAL

Shall the following resolution be adopted:

RESOLVED, that the Board of Education of the Kinderhook Central School District, Columbia and Rensselaer Counties, New York be authorized to (1) acquire four (4) SCHOOL BUSES, at a maximum aggregate cost of \$428,000; (2) expend such sum for such purpose; (3) levy of the necessary tax therefore (and to pay interest thereon), to be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Education taking into account state aid; and (4) in anticipation of the collection of such tax, issuance of bonds and notes of the District at one time or from time to time in the principal amount not to exceed \$428,000?

The Proposition shall appear on the ballot labels of the voting machines and in the absentee ballots in the following abbreviated form:

PROPOSITION

RESOLVED, that the Board of Education of the Kinderhook Central School District, Columbia and Rensselaer Counties, New York be authorized to acquire to acquire four (4) buses at a maximum aggregate cost of \$428,000, and providing that such sum (and the interest thereon) be raised by a tax levy to be collected in annual installments, with District obligations to be issued in anticipation thereof.
