Please be advised that the Ichabod Crane Central School District provides services to individuals pursuant to Title I-A of the No Child Left Behind Act. In general, the District uses these monies to provide remedial or Academic Intervention Services (AIS). Such services may be provided in the course of regular instruction or in a separate setting.

Currently the District has three Title I schools, Ichabod Crane Primary School, Ichabod Crane Elementary School and Ichabod Crane Middle School. Parents of a child attending any of these schools may request information regarding the professional qualifications of their child's classroom teacher(s) and paraprofessional staff. As such, parents may request information on the following:

- whether the teacher has met New York state certification criteria for the grade levels and subject areas in which the teacher provides instruction;
- whether the teacher is teaching under emergency or other provisional status through which state certification criteria have been waived;
- the baccalaureate degree major of the teacher and any other graduate certification or degree held by the teacher, and the field of discipline of the certification or degree; and,
- whether the child is provided services by paraprofessionals and, if so, their qualifications.

To obtain information about the professional background of any teacher in a Title I building, please contact the Superintendent's office at 758-7575, ext. 3002.


As part of the District's plan to maintain compliance with Title I, the District will provide parents with information about their child's level of performance on District-developed report cards. The schedule for the distribution of report cards is available to all families with children in the school and is printed in the District calendar or by calling 758-7575, ext. 3001.

As part of the District's plan to maintain compliance with Title I, the District will notify parents if their child has been assigned, or has been taught for four or more consecutive weeks, by a teacher who is not highly qualified.
