- The District agrees to continue the loan of the Painting to the Village, until such time as (a) the Village no longer uses the Martin H. Glynn building as Village offices; (b) the Village no longer continues to display the Painting at such Village offices.
- 2 Ownership of the Painting shall remain with the District and the District may retake possession of the Painting at any time, for any reason, in its sole discretion.
- 3 The Village agrees to properly maintain and provide appropriate security as warranted for this historical Painting
- 4 This resolution shall be subject to annual review by the District at its annual Organizational meeting
