### MINUTES

A Regular Meeting of the Ichabod Crane School Board was held on Tuesday, August 4, 2015 at 7:00 p.m. in the High School Library.

Board President Anthony Welcome called the meeting to order at 7:02 p.m.

**WHEREAS**, the **ICHABOD CRANE CENTRAL SCHOOL DISTRICT** (the "School District") and the **TOWN OF KINDERHOOK**, (the "Town") executed and delivered a certain deed, dated January 24, 1983 and recorded in the Columbia County Clerk's Office on February 4, 1983 at Liber 565 cp 1046

#### BOARD OF EDUCATION 08/04/15

(the "Deed") which deed was intended to convey all right, title and interest in the property where the Town of Kinderhook Town Hall is currently located and identified as 4 Church Street in the Town of Kinderhook, County of Columbia, State of New York currently known as SBL No.: 23.15-1-28 (the "Property") from the School District to the Town;

**WHEREAS**, the Deed from the School District to the Town only conveyed a portion of the Property and did not include the portion of the Property upon which the Town Hall is located;

**WHEREAS**, the School District agrees that the deed for the transfer of the Property must be corrected to reflect the conveyance of the portion of the Property upon which the Town Hall is located;

**WHEREAS**, the form of the Correction Deed, TP-584 form, Columbia County Supplemental Form and the RP-5217 are attached hereto as Exhibit "A".

**NOW THEREFORE**, the Board of Education has reviewed the documents annexed hereto at Exhibit "A" and the Board of Education approves the execution and delivery of the documents annexed hereto at Exhibit "A".

- Light Poles The district has options to proceed with the costs for the repair/replacement of the light poles at the athletic fields. The first option is to accept the offer from Valmont Industries which would pay for a portion of the expense to repair and reinstall the lights. The district could file an insurance claim, but the claim only covers direct damage from the one fallen pole and no money toward replacing the other three light poles which were removed to prevent further damage. The District could also choose litigation, however, that would be very expensive and could be lost, leaving the District with the cost of replacing the light poles and the cost of the lawsuit.
