Although not making a decision regarding allowing or disallowing the veterans' tax exemption, the Board did discuss the exemption, agreeing that the decision for allowing exemptions for veterans' should not belong to school boards.

# MOTION CHANDLER 2<sup>ND</sup> TREFZGER

Resolution Calling upon the Governor and Legislature of New York State to Amend Real Property Tax Law Section 458-a to Equitably Provide and Fund the Alternative Veterans Exemption as Applied to School District Taxes

WHEREAS, the Ichabod Crane Central School District is dedicated to preparing students to become contributing members of society in an ever-changing world by valuing diversity; providing a safe environment; and promoting unique talents, a desire for life-long learning, a strong spirit of community, and Rider pride; and

WHEREAS, in December of 2013, the Real Property Tax Law was amended to allow School Districts to offer a partial exemption from school property taxes to qualified properties owned by veterans; and

WHEREAS, the Ichabod Crane Central School District honors, recognizes, and sincerely appreciates all veterans for their vital contributions to our safety and well-being, and the preservation of our individual and collective rights and freedoms; and

WHEREAS, the Ichabod Crane Central School District believes veterans' health, education, safety, and well-being basic needs should be forever met by State and federal governments on an equitably funded basis; and

WHEREAS, the application of the Alternative Veterans Exemption from school property taxes is not based on the needs of veterans and is not equitably funded, as the exemption would simply result in lower school property taxes for the qualified properties owned by veterans and higher tax rates for properties owned by non-veterans; and

WHEREAS, should the Governor and Legislature feel the contributions and sacrifices of veterans be acknowledged by lowering their school property taxes, then the Governor and Legislature should also fund the exemption through equitable State revenue sources and reimburse School Districts for lost revenue;

NOW, THEREFORE BE IT RESOLVED, that we call upon the Governor and Legislature of New York State to reexamine and amend Real Property Tax Law Section 458-a to equitably provide and fund the Alternative Veterans Exemption as applied to School District taxes.

The Board directed the District Clerk to send copies of the resolution to the governor and state legislature.

# • Martin H Glynn Portrait

The District was contacted by the Village of Valatie regarding a portrait which hung in the Martin H Glynn School building. After borrowing this portrait from the school during the fall of 2014 for a celebration honoring Martin H Glynn, the village would like to continue to have the portrait hanging at the Valatie Village Hall (which is now housed in the old Martin H Glynn School Building). The District will contact the school attorney, discuss proposed School Board action with the Village and subsequently bring a resolution to Board for the January Regular meeting.
