- First 30 days (September 1-30) no penalty
- Second 30 days (October 1- October 31) 2% penalty

AND TO ESTABLISH the date of July 26, 2024 as the last date for accepting applications for third party notification of Real Property Taxes in accordance with Chapter 758 of the Laws of 1986
